WEIGHTED COUNTRY PRODUCT DUMMY VARIABLE REGRESSIONS AND INDEX NUMBER FORMULAE

The paper considers a very simple type of hedonic regression model where the only characteristic of a commodity is the commodity itself. This regression model is known as the country product dummy method for calculating country price parities in the context of making international comparisons. The paper considers only the two country or two period case and introduces value or quantity weights into the regression. The resulting measures of overall price change between the two countries or time periods are compared to traditional bilateral index number formulae. It is shown how the Geary Khamis, Walsh and Törnqvist price indexes can be obtained as special cases of this framework.

1. INTRODUCTION

The Country Product Dummy (CPD) method for making international comparisons of prices is a very simple type of hedonic regression model that was proposed by Robert Summers (1973) where the only characteristic of the commodity is the commodity itself. In this paper, we will consider how this simple hedonic regression model can be modified for the two country or two period case when quantity or expenditure weights are available in addition to the country (or “model”) prices. We will then relate these weighted versions of the CPD regression model to traditional index number formulae.¹

In Section, we consider the case where *expenditure weights* for the two periods or countries are available, while Section 3 considers the case where *quantity weights* are available.

2. THE CPD METHOD WHEN EXPENDITURE WEIGHTS ARE AVAILABLE

If there are C countries in the comparison² and N products, the relationship of the prices between the various countries using the CPD assumptions is approximately given by the following model:

$$(1) \quad p_n^c \approx \alpha_c \beta_n; \quad c = 1, \dots, C; \quad n = 1, \dots, N;$$

$$(2) \quad \alpha_1 = 1$$

where p_n^c is the price (in domestic currency) of commodity n in country c . Quantities for each commodity in each country are assumed to be measured in the same units. Equation (2) is an identifying normalization; i.e. we measure the price level of each country relative to the price level in country 1. Note that there are CN prices in the model and there are $C - 1 + N$ parameters to “explain” these prices. Note also that the basic hypothesis that is implied by (1) is that commodity prices are approximately proportional between the two countries. Taking logarithms of both sides of (1) and adding error terms leads to the following CPD regression model:

$$(3) \quad \ln p_n^c = \ln \alpha_c + \ln \beta_n + \varepsilon_n^c; \quad c = 1, \dots, C; \quad n = 1, \dots, N.$$

The main advantage of the CPD method for comparing prices across countries over traditional index number methods is that we can obtain *standard errors* for the country price levels $\alpha_2, \alpha_3, \dots, \alpha_C$. This advantage of the stochastic approach to index number theory was stressed by Summers (1973) and more recently by Selvanathan and Rao (1994).

We will consider a special case of the above model where there are only two countries but we will generalize the above model to allow for expenditure weights. Our reason for considering only the case of two countries is that we want to compare our weighted CPD estimator for α_2 with traditional bilateral index number formulae.³ Thus let

$$(4) \quad e_n^c \equiv p_n^c q_n^c; \quad c = 1, 2; \quad n = 1, \dots, N$$

denote the expenditure on commodity n in country c and consider the following *weighted least squares model*:⁴

$$(5) \quad \min_{\gamma, \delta} \sum_{n=1}^N e_n^1 [\ln p_n^1 - \delta_n]^2 + \sum_{n=1}^N e_n^2 [\ln p_n^2 - \gamma - \delta_n]^2$$

where $\gamma \equiv \ln \alpha_2$ and $\delta_n \equiv \ln \beta_n$ for $n = 1, \dots, N$. In order to make the second summation of terms comparable to the first, prices should be measured in the same currency units.⁵ In order to justify the model (5) in terms of a traditional stochastic specification, assume that $\ln p_n^c$ is an independently distributed random variable with mean δ_n and variance σ^2/e_n^1 and $\ln p_n^2$ is an independently distributed random variable with mean $\delta_n + \gamma$ and variance σ^2/e_n^2 . An alternative way for justifying the weighted model (5) is to argue that each logarithmic price $\ln p_n^1$ should be weighted according to its economic importance; i.e. if consumers are spending e_n^c dollars on

commodity n in country c , then $\ln p_n^c$ should appear e_n^c times in the regression instead of only once.⁶ This assumption also leads to (5).

The solution for γ which solves the above weighted least squares minimization problem is

$$(6) \quad \gamma^* = \sum_{n=1}^N S_n \ln(p_n^2/p_n^1)$$

where

$$(7) \quad S_n \equiv h(e_n^1, e_n^2) / \sum_{i=1}^N h(e_i^1, e_i^2); \quad n = 1, \dots, N \text{ and}$$

$$(8) \quad h(a, b) \equiv [(1/2)a^{-1} + (1/2)b^{-1}]^{-1} = 2ab/[a + b]$$

so that $h(a, b)$ is the *harmonic mean* of the numbers a and b . Thus γ^* is a share weighted average of the logarithms of the price ratios p_n^2/p_n^1 . If γ^* is exponentiated, then an estimator α_2^* for α_2 , the price level of country 2 relative to country 1, is obtained.

It can be seen that if countries 1 and 2 are interchanged, then the corresponding weighted least squares estimator for the price level of country 1 relative to that of country 2 turns out to equal the reciprocal of α_2^* , i.e. the exponential of γ^* defined by (6) satisfies the *time reversal test*.⁷ This is a very desirable property for an index number formula.

Note that if country 2 is much bigger than country 1, then the expenditure weights of country 2, the e_n^2 , will play a much larger role in the shares S_n defined by (7) than the expenditure weights of country 1, the e_n^1 . Thus weighting by country expenditures leads to a *plutocratic* type index number formula where the bigger country plays a larger role in determining the relative price level. In order to eliminate this asymmetry and obtain a *democratic* type of index where each country has equal weighting no matter what its size is, we can replace the expenditure weights in the weighted least squares problem (5) by *expenditure shares*. Thus let

$$(9) \quad s_n^c \equiv p_n^c q_n^c / \sum_{i=1}^N p_i^c q_i^c; \quad c = 1, 2; \quad n = 1, \dots, N$$

denote the expenditure share for commodity n in country c and consider the following *weighted least squares model*:⁸

$$(10) \quad \min_{\gamma, \delta_n} \sum_{n=1}^N s_n^1 [\ln p_n^1 - \delta_n]^2 + \sum_{n=1}^N s_n^2 [\ln p_n^2 - \gamma - \delta_n]^2$$

where $\gamma \equiv \ln \alpha_2$ and $\delta_n \equiv \ln \beta_n$ for $n = 1, \dots, N$. In order to justify the model (10) in terms of a traditional stochastic specification, assume that $\ln p_n^1$ is an independently distributed random variable with mean δ_n and variance σ^2/s_n^1 and $\ln p_n^2$ is an independently distributed random variable with mean $\delta_n + \gamma$ and variance σ^2/s_n^2 .

The solution for γ which solves the above weighted least squares minimization problem is

$$(11) \quad \gamma^{**} = \sum_{n=1}^N S_n^* \ln(p_n^2 / p_n^1)$$

where

$$(12) \quad S_n^* \equiv h(s_n^1, s_n^2) / \sum_{i=1}^N h(s_i^1, s_i^2); \quad n = 1, \dots, N.$$

Thus γ^{**} is another share weighted average of the logarithms of the price ratios p_n^2/p_n^1 . If γ^{**} is exponentiated, then an estimator α_2^{**} for α_2 , the price level of country 2 relative to country 1, is obtained. Let us call the bilateral index α_2^{**} the *harmonic share weights log price change index* or more briefly, the *harmonic share weights index*.

It can be shown⁹ that α_2^{**} approximates the *Törnqvist index* to the second order around an equal price and quantity point; i.e. for most data sets, the harmonic share weights index will be very close to the Törnqvist index.¹⁰ Thus the weighted hedonic regression model defined by (10) leads to a bilateral index number formula which will be reasonably close to a superlative index number formula.¹¹

Instead of weighting the period 1 logarithmic prices by the corresponding period 1 shares and the period 2 prices by the period 2 shares, we could weight both prices by the arithmetic average of the two expenditure shares. Thus consider the following *weighted least squares model*:¹²

$$(13) \quad \min_{\gamma, \delta_n} \sum_{n=1}^N (1/2)(s_n^1 + s_n^2)[\ln p_n^1 - \delta_n]^2 + \sum_{n=1}^N (1/2)(s_n^1 + s_n^2)[\ln p_n^2 - \gamma - \delta_n]^2$$

where as usual, $\gamma \equiv \ln \alpha_2$ and $\delta_n \equiv \ln \beta_n$ for $n = 1, \dots, N$. In order to justify the model (13) in terms of a traditional stochastic specification, assume that $\ln p_n^1$ is an independently distributed random variable with mean δ_n and variance $\sigma^2/(1/2)(s_n^1 + s_n^2)$ and $\ln p_n^2$ is an independently distributed random variable with mean $\delta_n + \gamma$ and variance $\sigma^2/(1/2)(s_n^1 + s_n^2)$.¹³ The solution for γ which solves the above weighted least squares minimization problem turns out to be:

$$(14) \quad \gamma^{***} = \sum_{n=1}^N (1/2)(s_n^1 + s_n^2) \ln(p_n^2 / p_n^1).$$

It can be seen that γ^{***} is the logarithm of the Törnqvist (1936) price index and hence if γ^{***} is exponentiated, then an estimator α_2^{***} for α_2 , the price level of country 2 relative to country 1, is obtained. This estimator is the Törnqvist price index. Given that the Törnqvist price index is a superlative index number formula, it appears that choosing the weights in a weighted CPD regression to be the arithmetic average of the expenditure shares is a reasonable choice, provided that there are positive expenditures on all N goods for both countries.

Finally, consider the following *unweighted version* of the least squares minimization problem (5), (10) or (13):

$$(15) \quad \min_{\gamma, \delta^s} \sum_{n=1}^N [\ln p_n^1 - \delta_n]^2 + \sum_{n=1}^N [\ln p_n^2 - \gamma - \delta_n]^2$$

which is the original CPD method specialized to 2 countries. Let γ^{****} solve (15). It can be shown that:

$$(16) \quad e^{\gamma^{****}} = P_J(p^1, p^2) \equiv \prod_{n=1}^N [p_n^2 / p_n^1]^{1/N}$$

and $P_J(p^1, p^2)$ is the *Jevons (1865) price index* between countries 1 and 2.

3. A MODIFIED CPD REGRESSION MODEL WHEN QUANTITY WEIGHTS ARE AVAILABLE

In the previous section, we suggested weighting prices in each country by their economic importance. But how exactly should “economic importance” be measured? In Section 2, we initially suggested that the country’s expenditure on each commodity was a reasonable indicator of economic importance. However, we eventually rejected this initial suggestion since it led to an asymmetry in weighting when a large country was being compared to a small country. Thus we eventually ended up suggesting country expenditure shares as reasonable weights that reflected the relative economic importance of each price in each country and this led to the harmonic share weights index. In this section, instead of using *expenditures* on a commodity as an indicator of the economic importance of the commodity, we start out by suggesting that perhaps the *quantities purchased* could serve as indicators of economic importance. Unfortunately, we shall find that this approach is ultimately not very successful although at the end, we will succeed in providing a (rather tortured) justification for the Geary (1958) Khamis (1970, 1972) bilateral index number formula using this “quantities as weights” approach.

Thus, instead of taking logarithms of prices and weighting by expenditure shares as in (10) or (13) above, we could consider the following *weighted least squares regression model where we weight by quantities sold* q_n^c in each country:¹⁴

$$(17) \quad \min_{\alpha, \beta^s} \sum_{n=1}^N q_n^1 [p_n^1 - \beta_n]^2 + \sum_{n=1}^N q_n^2 [p_n^2 - \alpha_2 \beta_n]^2.$$

However, there are a number of problems with the α_2 solution to the above least squares problem. One of the biggest problems is that the resulting index number formula is not invariant to changes in the units of measurement. This is a fatal flaw.¹⁵

In order to deal with this invariance problem, we consider replacing the prices p_n^c , which are the dependent variables in the regression model, by a transformation of these prices. A very simple transformation is the power transformation. Thus let ρ be a nonzero number and replace p_n^1 by $(p_n^1)^\rho$. Using (1) and (2), $(p_n^1)^\rho$ is approximately equal to

$$(18) \quad (\beta_n)^\rho \equiv \delta_n; \quad n = 1, \dots, N.$$

The country 2 price for commodity n , p_n^2 is replaced by $(p_n^2)^\rho$, and using (1), $(p_n^2)^\rho$ is approximately equal to $(\alpha_2 \beta_n)^\rho = \alpha_2^\rho \beta_n^\rho = \gamma \delta_n$, where γ is defined as follows:

$$(19) \quad \gamma \equiv \alpha_2^\rho.$$

The weighted least squares regression model that is the counterpart to (17), except that prices p_n^1 and p_n^2 are replaced by transformed prices $(p_n^1)^\rho$ and $(p_n^2)^\rho$ respectively (and using definitions (18) and (19) to reparameterize the β_n and α_2), is:

$$(20) \quad \min_{\gamma, \delta_n} \sum_{n=1}^N q_n^1 [(p_n^1)^\rho - \delta_n]^2 + \sum_{n=1}^N q_n^2 [(p_n^2)^\rho - \gamma \delta_n]^2.$$

There are two problems with the weighted least squares problem (20):

- We cannot obtain a closed form solution for the key parameter γ .
- The price levels in the two countries could be quite different and hence the prices of the country with the higher price level could get too much weight in (20); put another way, there could be a heteroskedasticity problem.

Both of these problems can be solved if we divide the country 2 transformed prices $(p_n^2)^\rho$ by the transformed index of country 2's prices relative to country 1's prices, α_2^ρ , which is equal to γ . Performing this division, the weighted least squares problem (20) becomes:

$$(21) \quad \min_{\phi, \delta_n} \sum_{n=1}^N q_n^1 [(p_n^1)^\rho - \delta_n]^2 + \sum_{n=1}^N q_n^2 [(p_n^2)^\rho \phi - \delta_n]^2$$

where the new parameter ϕ is defined as

$$(22) \quad \phi \equiv 1/\gamma = 1/\alpha_2^\rho.$$

In order to justify the weighted least square model (21) in terms of a traditional stochastic specification, assume that $(p_n^1)^\rho$ is an independently distributed random variable with mean δ_n and variance σ^2/q_n^1 and $(p_n^2)^\rho$ is an independently distributed random variable with mean $\delta_n \gamma$ and variance $\gamma^2 \sigma^2/q_n^2$.

The solution for ϕ which solves the above weighted least squares minimization problem is

$$(23) \quad \phi^* = \sum_{n=1}^N h(q_n^1, q_n^2)(p_n^1)^\rho (p_n^2)^\rho / \sum_{n=1}^N h(q_n^1, q_n^2)(p_n^2)^\rho (p_n^1)^\rho$$

where $h(q_n^1, q_n^2)$ is the harmonic mean of the consumption of commodity n for country 1 and 2. It is evident that ϕ^* is not invariant to changes in the units of measurement for each commodity unless $\rho = 1/2$. Hence, in what follows, we assume:

$$(24) \quad \rho = 1/2$$

Using assumption (24) and definition (19), the ϕ^* defined by (23) translates into the following estimator for the price level of country 2 relative to that of country 1:

$$(25) \quad \alpha_2^* = \left[\sum_{n=1}^N h(q_n^1, q_n^2) p_n^2 / \sum_{n=1}^N h(q_n^1, q_n^2)(p_n^1)^{1/2} (p_n^2)^{1/2} \right]^2.$$

The index number formula defined by (25) is a bit strange looking but it does have some of the usual properties of bilateral indexes, such as being homogeneous of degree one in the prices of country 2 and homogeneous of degree minus one in the prices of country 1.¹⁶ Unfortunately, the index defined by (25) does not satisfy the important time reversal test.¹⁷

In order to remedy this last defect, we make use of Fisher's (1922, pp. 136–40) rectification procedure.¹⁸ Instead of letting country 1 play the role of the base country, we can let country 2 be the base country; i.e. replace the normalization (2), $\alpha_1 = 1$, with $\alpha_2 = 1$. Repeating the above analysis with this change leads to the following estimator for the price level of country 1 relative to that of country 2:

$$(26) \quad \alpha_1^* = \left[\sum_{n=1}^N h(q_n^1, q_n^2) p_n^1 / \sum_{n=1}^N h(q_n^1, q_n^2)(p_n^1)^{1/2} (p_n^2)^{1/2} \right]^2.$$

Now use $1/\alpha_1^*$ as an estimator for the price level of country 2 relative to that of country 1 and finally, take the geometric mean of α_2^* defined by (25) and $1/\alpha_1^*$ where α_1^* is defined by (26) to obtain our *final estimator of the price level of country 2 relative to that of country 1*:

$$(27) \quad \alpha^* = [\alpha_2^* / \alpha_1^*]^{1/2} = \sum_{n=1}^N h(q_n^1, q_n^2) p_n^2 / \sum_{n=1}^N h(q_n^1, q_n^2) p_n^1 \equiv P_{GK}(p^1, p^2, q^1, q^2)$$

where as usual, $h(q_n^1, q_n^2)$ is the harmonic mean of the consumption of commodity n for country 1 and 2. It can be seen that the bilateral index number formula α^* defined by (27) is actually the *Geary (1958) Khamis (1970, 1972) bilateral index number formula*, $P_{GK}(p^1, p^2, q^1, q^2)$. This formula was advocated by Geary and Khamis in the more general context of making multilateral price and quantity comparisons between many countries but their more general formula boils down to the above index in the case of two countries. This formula was also considered by Irving Fisher (1922, p. 485) as his index number formula 3153.

Recall that the *Marshall (1887), Edgeworth (1925) and Walsh (1901) bilateral index number formulae* can be defined as follows:

$$(28) \quad P_{ME}(p^1, p^2, q^1, q^2) \equiv \sum_{n=1}^N (1/2)(q_n^1 + q_n^2)p_n^2 / \sum_{n=1}^N (1/2)(q_n^1 + q_n^2)p_n^1;$$

$$(29) \quad P_W(p^1, p^2, q^1, q^2) \equiv \sum_{n=1}^N (q_n^1 q_n^2)^{1/2} p_n^2 / \sum_{n=1}^N (q_n^1 q_n^2)^{1/2} p_n^1.$$

Comparing (28) and (29) with the Geary Khamis index defined by (27), it can be seen that all three indexes are of the fixed basket type. The basket being compared is the harmonic, arithmetic and geometric mean of the baskets pertaining to the two countries respectively. All three indexes will approximate each other to the second order around an equal price and quantity point.¹⁹ Thus while the Geary Khamis bilateral index number formula is not superlative, it will approximate a superlative index to the second order around an equal price and quantity point.²⁰

It is possible to obtain the Walsh price index directly by considering weighted least squares regression models of the type defined by (20) above: replace the quantity weights q_n^1 by q_n^{1*} and q_n^2 by q_n^{2*} and repeat all of the steps (22) to (27) for these new weights. We end up with the following estimator for *the price level of country 2 relative to that of country 1*:

$$(30) \quad \alpha^{**} = \sum_{n=1}^N h(q_n^{1*}, q_n^{2*})p_n^2 / \sum_{n=1}^N h(q_n^{1*}, q_n^{2*})p_n^1$$

where as usual, $h(q_n^{1*}, q_n^{2*})$ is the harmonic mean of q_n^{1*} and q_n^{2*} . Now choose the quantity weights q_n^{1*} and q_n^{2*} as follows:

$$(31) \quad q_n^{1*} \equiv [q_n^1 q_n^2]^{1/2}; \quad q_n^{2*} \equiv [q_n^1 q_n^2]^{1/2}.$$

Thus the weights for commodity n for both periods, q_n^{1*} and q_n^{2*} , are chosen to be the geometric mean of the period 1 and 2 quantities for commodity n , $[q_n^1 q_n^2]^{1/2}$. If we substitute the weights q_n^{1*} and q_n^{2*} defined by (31) into (30), we find that α^{**} is the Walsh price index P_W defined by (29).

Note that an unweighted version of the index defined by (27) above can be obtained if we consider an unweighted version of the least squares problem (21); i.e. if we set:

$$(32) \quad q_n^1 = q_n^2 = 1; \quad n = 1, 2, \dots, N.$$

Under these conditions, α^* defined by (27) becomes:

$$(33) \quad P_D(p^1, p^2) \equiv \sum_{n=1}^N (1/N)p_n^2 / \sum_{n=1}^N (1/N)p_n^1$$

where $P_D(p^1, p^2)$ is the *Dutot* (1738) *price index* between countries 1 and 2.²¹

4. CONCLUSION

At first glance, it seems that the Country Product Dummy method (and by extension, unweighted hedonic regression methods) for comparing prices between countries (or time periods) is totally unrelated to traditional index number methods for making price comparisons between two countries or time periods. However, in this note, we have shown that if *unweighted* Country Product Dummy (or hedonic) regressions are replaced by suitable *weighted* counterparts, then the resulting measures of price change are very closely related to traditional bilateral index number formulae. If expenditure share weights are used and the dependent variable is the logarithm of price, then the *harmonic share weights index*, the exponential of γ^{**} defined by (11) and (12), is the resulting weighted CPD estimator of the price level of country 2 relative to country 1. If the individual period shares are replaced by the arithmetic average of the shares for both sets of weights, then the exponential of γ^{***} defined by (14) turns out to be the Törnqvist price index. If quantity weights are used and the dependent variable is the square root of price, then after averaging two estimators, the Geary Khamis index defined by (27) is the resulting weighted CPD estimator of the price level of country 2 relative to country 1. If geometric average quantity weights are used as weights for both periods, then after averaging two estimators, the Walsh price index defined by (29) is the resulting estimator of the price level of country 2 relative to country 1.

The corresponding unweighted estimators of the price level of country 2 relative to that of country 1 turn out to be the Jevons index defined by (16) and the Dutot index defined by (33). *These unweighted indexes can be very far from their weighted counterparts.* Thus the main conclusion that we draw from this note is that in running Country Product Dummy regressions or hedonic regressions in the time series context, *it is very important to run appropriately weighted versions of these regressions in order to obtain more accurate estimates of price levels.*
